Notice Concerning Treatment of Agreements to be Retained by the Holding Company

We extend our sincere wishes on your company's continued success, and thank you for your continued support and business.

As we previously informed you, with the transition of the Company to a holding company structure (Note 1) as of July 1, 2023, the agreements for businesses for which the Company places orders to your company and which mainly belong to the domestic business of the Company will be transferred to the Domestic Operating Company and will continue to be in effect between your company and the Domestic Operating Company. We also informed you that we would further notify you in due course of such agreements that will not be transferred to the Domestic Operating Company and will be retained by the Holding Company.

Accordingly, we hereby notify you of the matters in relation to the agreements that will be retained by the Holding Company as follows.

1. Agreements to be retained by the Holding Company

As for the individual agreements and basic agreements for businesses for which the Company places orders to your company, both of which relate to the Company's segments listed in <Table 1> below, such agreements will be retained by the Holding Company and will continue to be in effect between your company and the Holding Company. Therefore, on and after July 1, 2023, please replace "NTT DATA Corporation" with "NTT DATA GROUP CORPORATION" as the party to such agreements.

Note 1: Holding Company Structure

NTT DATA Corporation (referred to herein as the “**Company**”) will transition to a holding company structure as of July 1, 2023, and conduct a company split in which the domestic business of the Company will be succeeded to by NTT DATA Japan Preparation Corporation (referred to herein as the “**Preparation Company**”), making the Preparation Company the domestic operating company. On the same date, the company name of the Company will be changed to “NTT DATA GROUP CORPORATION” (referred to herein as the “**Holding Company**”) and the company name of the Preparation Company will be changed to “NTT DATA JAPAN CORPORATION” (referred to herein as the “**Domestic Operating Company**”).

The transition to a holding company structure and changes of the company names are subject to approval at the Company’s general meeting of shareholders, which is planned to be held in June 2023.

Notice Concerning Treatment of Agreements in Connection with Transfer of Domestic Business

We extend our sincere wishes on your company's continued success, and thank you for your continued support and business.

NTT DATA Corporation (the "**Company**") hereby announces that, effective July 1, 2023, the Company will transition to a holding company structure and conduct a company split in which the domestic business of the Company will be transferred to NTT DATA Domestic Business Preparation Company, Inc. (the "**Preparation Company**") (the "**Company Split**"), making the Preparation Company the domestic operating company. On the same date, the company name of the Company is planned to be changed to "NTT DATA GROUP CORPORATION" (referred to below as the "**Holding Company**") and the company name of the Preparation Company is planned to be changed to "NTT DATA JAPAN CORPORATION" (referred to below as the "**Domestic Operating Company**").

The transition to a holding company structure and changes of the company names are subject to approval at the Company's general meeting of shareholders scheduled to be held in June 2023. However, we would like to inform you in advance of matters related to the business with your company after the transition to a holding company structure, as below.

1. Existing agreements with your company

(1) Individual Agreements

Effective July 1, 2023 (tentative), among the agreements for the business already ordered from the Company to your company (including agreements for the business to be ordered by the Company to your company by the day immediately preceding the effective date of the Company Split (tentatively, June 30, 2023)), individual agreements which are in effect and falling under solely to the domestic business of the Company will be transferred to the Domestic Operating Company as a result of the Company Split and will continue to be in effect between your company and the Domestic Operating Company.

On the other hand, such as mostly the agreements with the departments which will not be transferred to the Domestic Operating Company from the Company (i.e., departments to be left at the Holding Company), since individual agreements which do not fall under solely to the domestic business of the Company will not be transferred to the Domestic Operating Company, such individual agreements will continue to be in effect between your company and the Holding Company. On or after July 2023, we will notify you in due course of such agreements which will not be transferred to the Domestic Operating Company.

(2) Basic Agreements

Among the basic agreements entered into between the Company and your company (including basic agreements to be entered into between your company and the Company by the day immediately preceding the effective date of the Company Split (tentatively, June 30, 2023)), basic agreements which are in effect will be transferred to the Domestic Operating Company as a result of the Company Split becoming effective and will continue to be in effect between your company and the Domestic Operating Company.

On the other hand, as for the basic agreements which the Holding Company would also like to continue to have in effect with your company under the same terms and conditions of the previous agreements, we will ask you to enter into such agreement on or after July 2023. Until such basic agreement is entered into with the Holding Company, a special provision, confirming that the provisions of the basic agreement previously entered into between your company and the Company will continue to apply between your company and the Holding Company on or after July 2023, may be included in an individual agreement between your company and the Holding Company.

(3) Partnership Agreements

Effective July 1, 2023 (tentative), among the partnership agreements entered into between your company and the Company (including partnership agreements to be entered into between your company and the Company by the day immediately preceding the effective date of the Company Split (tentatively, June 30, 2023)), partnership agreements which are in effect will be transferred to the Domestic Operating Company as a result of the Company Split and will continue to be in effect between your company and the Domestic Operating Company.

We will notify you in due course on or after July 2023 in case there are partnership agreements which will not be transferred to the Domestic Operating Company as a result of the Company Split.

***If your company has not raised any objections by the end of May 2023 regarding the treatment of agreements entered into with your company and referred to in (1) through (3) above, your company will be deemed to have agreed to such treatment.**

2. Invoices from your company after the transition to a holding company structure

Please issue invoices to the Holding Company in relation to agreements that will not be transferred to the Domestic Operating Company, and to the Domestic Operating Company in relation to agreements that will be transferred to the Domestic Operating Company. Please contact the person in charge of the relevant matter for details on such as where to issues your invoices.
